Lottery Rules

1. Open to anyone interested in being a Sandy Beach County Park Seasonal Camper
2. Participants must have a valid State ID that matches their Camping Unit Registration

Lottery Procedure

1. Lottery tickets can be picked up starting Saturday, July 13, 2019 at 11 AM in the Sandy Beach County Park office until 8:30am on August 10, 2018. There is a \$20 administrative fee for each corresponding lotto registration.
 - a. Only one ticket may be allowed per person and camping unit; If a camping unit is entered more than one time, all involved are disqualified
 - b. The administrative fees are non-refundable and non-transferable (does not count towards site payment); Tickets will not be re-issued if lost or stolen
 - c. You must have the original ticket in order to claim a site
 - d. The participant must provide their State ID as well as camping unit registration, to be eligible to receive a ticket
 - i. The clerk will record this information (ticket number, name, address, make, model, and plate number) on the lotto registration form
 - ii. To be eligible, the ID and Registration info must match
2. The drawing begins at 9 am on Saturday, August 10th, 2019. The first name drawn will receive the first pick of eligible campsites and boat slips (Slips 3-26). The second name drawn will receive a second pick of eligible sites and slips remaining, and so on. You or your representative* must be present when the ticket is drawn.
 - a. The ticket pulled and the ticket returned by the winner must match, as well as the ticket number located on the lotto registration
 - i. Winners must present their ID and Camping Unit Registration
 1. This information must exactly match the lotto registration form
 2. Winners must be present, in person, to be eligible
 - a. *If they cannot attend, only one individual (representative), may provide a copy of the winner's ID and Camping Unit Registration. No exceptions will be made.
 - ii. Once verified, the winner/representative must go, with their validated lotto registration form, to the Sandy Beach Office and pay the \$200, non-refundable, seasonal deposit. The Seasonal Agreement Must Be signed at this time. If payment is not made, or the

agreement is not signed, at this time the winner forfeits the site and slip, and the campsite becomes available to those on the waiting list.

3. When all campsites and/or slips are gone, all tickets remaining will be picked and recorded in order on a waiting list
 - a. On December 6th, waiting list customers will be called if there are openings
 - b. If a person declines a site(of any type), they are removed from the list
 - c. \$200 deposit will be required at that time to reserve the campsite
4. Seasonal Campers must pay their sites in full after November 1st, 2019 and before Friday March 20th 2020 at 5pm; no partial or late payments, or postdated checks will be accepted.
5. Any unclaimed seasonal sites after March 20, 2020 may be filled or designated transient, by Newaygo County Parks at their sole discretion.
6. Site changes will be allowed during the two first weeks, May 1 - May 15, of the 2020 camping season
 - a. Traded sites must be the same type (i.e. electric for electric)
 - b. The trade must be mutually agreed upon and done in person, only, with the Park Manager present
 - c. Both parties must fill out a site trade form
7. In order to secure a seasonal boat slip one must also select a seasonal campsite and pay the \$200 deposit for the campsite.

- Park Closes 9pm on October 11, 2020
